WHEREAS, the municipal governing body of the City of Leeds met on this 2nd day of September, 2025, in special session, a quorum thereof being present, at **12:00 p.m.**, and has canvassed the returns, and has ascertained and determined the number of votes received by each candidate, and

WHEREAS, the said municipal governing body has ascertained and determined the result of said election as follows:

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Leeds, Alabama, as follows:

1. That Cary Kennedy received a majority of the votes cast for the office of City Council-District 3 and is hereby declared duly elected to that office for the term beginning on the first Monday in November 2025.

2. That Ryan Holtbrooks received a majority of the votes cast for the office of City Council-District 4 and is hereby declared duly elected to that office for the term beginning on the first Monday in November 2025.

3. That Dale Faulkner received a majority of the votes cast for the office of City Council-District 5 and is hereby declared duly elected to that office for the term beginning on the first Monday in November 2025.

4. The respective Certificates of Election shall be issued accordingly.

5. That no candidate received a majority of the votes cast for the office of Councilmember District 1, and that Sabrina Rose and Lee Kelly received the most and second most votes cast for the office, respectively, therefore, a runoff election between these candidates is hereby ordered to be held on Tuesday, September 23, 2025, pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended.

6. No candidate received a majority of the votes cast for the office of Mayor, and Eddie Moore and Kenneth Washington received the most and second-most votes. Therefore, a runoff election between these candidates is hereby ordered to be held on Tuesday, September 23, 2025, pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended.
